# River Oaks Senior Men's Meeting Minutes

## Call to order

A meeting of the Senior Men's Club was held at River Oaks Golf Club on Monday, July 27, 2015.

## Approval of minutes

The minutes from the last meeting held May 25, 2015 were reviewed and approved.

## Reports

**Financial Statement:** Bill Chishom updated the members of the status of funds for the membership. He reported that spendable cash on hand was \$1,158.00 and the rang fund was at \$516.00. The hole in one prize has not been claimed.

**Single Match Play:** Trevor Hill reminded the members of the deadline for the semi final match play is September 8 and that there were only a few matches remaining to be played.

**Handicaps:** Dave Ryan updated the members on the process for using handicaps on the courses from the various tee boxes and how they should be applied during play of matches and stroke play.

**Senior Men's Club Championship:** Trevor Hill reminded the members that the tournament will take place on August 8, 9, 2015 with a 9am start. There is to be a committee meeting Monday, August 3, 2015 after the rang game to organize the procedures to be used for the upcoming tournament. Trevor reminded everyone that they must sign the sheet in order to be able to play. There would be no late registrations accepted with phone calls or emails.

**Today's Tournament:** The play for the day would be Pinehurst using a shotgun start with closest to pin on holes 5, 7, 17. Trevor had to rearrange team members as some members who had signed up did not show. Some members decided not to play as the weather conditions deteriorated quickly and only a few teams teed off. The game was called after five holes as conditions became unplayable and the entry fees were going to be applied to the next tournament.

## Other business

Larry Gladue made the members aware that rangs were incorrectly given out on June 24, 2015 with less than 16 players playing and that if the members wanted to change the procedure for rangs that they had to have it changed at a meeting first by putting forth a motion. Bill Chisholm had a short discussion about why it should be changed before it was decided by the members to change the procedure.

## Motion

A motion was presented by Andy McGowan to have the number of players changed from the current 16 players to 12 players. Larry Gladue seconded the motion. Discussion on the motion was conducted and two votes were done to determine if it passed as the count on the first vote was not clear. The motion passed with the second vote. Dave Ryan then made another motion to have the number of players changed from 12 to 14 players. He did not get a seconder on the motion. There was a quick vote with members in favor of the motion but it could not pass as the motion was not properly seconded and presented to the members. The motion was not redone so it stands that there needs to be 12 players in a sanctioned round to qualify for rangs.
